Order no. 791/24.03.2020 of the Ministry of Economy, Energy and Business Environment, was published in the Official Gazette no. 248/25.03.2020, concerning the granting emergency certificates to economic operators whose activity is affected in the context of the SAR-CoV-2 pandemic

Instruction no 2/17.03.2020 of the Financial Supervisory Authority was published in the Official Gazette no. 249/26.03.2020, to amend Annexs no. 1-4 of the Financial Supervisory Authority instruction no. 1/2016 on drawing up and submitting of annual financial statements and annual reporting by entities authorized, regulated and supervised by Financial Supervisory Authority - Financial instruments and investment sector
