Agentia Nationala de Administrare Fiscala reaminteste ca termenul limita de depunere a notificarii, prin care se manifesta intentia de a beneficia de masura de restructurare a obligatiilor bugetare restante, este data de **30 septembrie 2020**. Se incadreaza la aceasta facilitate toti contribuabilii care inregistreaza obligatii bugetare restante la data de 31.07.2020 si care doresc sa isi restructureze aceste obligatii bugetare potrivit prevederilor Cap. I din Ordonanta Guvernului nr. 6/2019 privind instituirea unor facilitati fiscale, cu modificarile si completarile ulterioare, avand insa sarcina sa notifice organul fiscal competent cu privire la aceasta intentie.

**We present below the press release of the National Agency for Tax Administration dated 25.09.2020 regarding the deadline for submitting the notification regarding the intention to restructure the budgetary obligations**

We reproduce the full text of the press release:

The National Agency for Tax Administration recalls that the deadline for submitting the notification, which shows the intention to benefit from the measure of restructuring the outstanding budget obligations, is **September 30<sup>th</sup>, 2020**. This facility includes all taxpayers who register outstanding budget obligations at dated 31.07.2020 and who wish to restructure these budgetary obligations according to the provisions of Chap. I of the Government Ordinance no. 6/2019 regarding the establishment of some fiscal facilities, with the subsequent modifications and completions, having the task to notify the competent fiscal body regarding this intention.

After this deadline, taxpayers are disqualified from the right to benefit from the restructuring of their budgetary obligations.

Taxpayers, who submit notifications until September 30<sup>th</sup>, 2020 and who maintain their
