Ordonanta de urgenta nr. 182/2020 pentru completarea Ordonantei de urgenta a Guvernului nr. 147/2020 privind acordarea unor zile libere pentru parinti in vederea supravegherii copiilor, in situatia limitarii sau suspendarii activitatilor didactice care presupun prezenta efectiva a copiilor in unitatile de invatamant si in unitatile de educatie timpurie anteprescolara, ca urmare a raspandirii coronavirusului SARS-CoV-2, precum si a art. 6 din Ordonanta de urgenta a Guvernului nr. 132/2020 privind masuri de sprijin destinate salariatilor si angajatorilor in contextul situatiei epidemiologice determinate de raspandirea coronavirusului SARS-CoV-2, precum si pentru stimularea cresterii ocuparii fortei de munca

In vigoare de la 27 octombrie 2020

OUG nr. 147/2020 privind acordarea unor zile libere pentru parinti in vederea supravegherii copiilor, se completeaza astfel:

- Se acorda zile libere pentru supravegherea copiilor si pentru parintele sau reprezentantul legal care are in ingrijire, supraveghere si intretinere unul sau mai multi copii scolarizati, cu boli cronice pentru care medicul de familie sau medicul specialist a emis adeverinte pentru realizarea educatiei;

Parintele/tutorele va depune la angajator urmatoarele documente:

- Cererea in care solicita zilele libere;
- Declaratie pe propria raspundere a

Emergency Ordinance no. 182/2020 for completing the Government Emergency Ordinance no. 147/2020 regarding the granting of free days for parents in order to supervise children, in case of limitation or suspension of teaching activities that involve the actual presence of children in schools and early childhood education units, as a result of the spread of SARS-CoV-2 coronavirus , as well as art. 6 of the Government Emergency Ordinance no. 132/2020 on support measures for employees and employers in the context of the epidemiological situation caused by the spread of SARS-CoV-2 coronavirus, as well as to stimulate employment growth

In force since October 27th , 2020

GEO no. 147/2020 regarding the granting of free days for parents in order to supervise children, is completed as follows:

- Free days are also granted for the supervision of the children for the parent or legal representative who has in care, supervision and maintenance one or more school children, with chronic diseases for which the family doctor or specialist doctor has issued certificates for education;

The parent/guardian will submit the following documents to the employer:

- The request in which he requests the free days;

- celuilalt parinte din care sa reiasa ca nu a solicitat la locul sau de munca zile libere;
- copie a certificatului/certificatelor de nastere al/ale copilului/copiilor sau a documentului care atesta calitatea de parinte/adoptator/tutore etc;
- O copie a certificatului de incadrare in grad de handicap al copilului ori adultului in varsta de pana la 26 de ani, daca este cazul;
- O copie a adeverintei eliberate de medicul de familie/medicul specialist.

Prevederile prezentei ordonante de urgenta se aplica si in situatiile in care s-a stabilit aplicarea scenariului 2 «Participarea zilnica a tuturor prescolarilor si elevilor din invatamantul primar, a elevilor din clasele a VIII-a si a XII-a, cu respectarea si aplicarea tuturor normelor de protectie si Revenirea partiala prin rotatie de 1-2 saptamani a elevilor din celelalte clase de gimnaziu si liceu, cu respectarea si aplicarea tuturor normelor de protectie», respectiv a scenariului 3 «Participarea tuturor prescolarilor si elevilor la activitati/lectii online».

Masura acordarii zilelor libere pentru supraveghera copilului se aplica pe perioada starii de alerta instituita potrivit Legii nr. 55/2020 privind unele masuri pentru prevenirea si combaterea efectelor pandemiei de COVID-19, numai dupa aplicarea de catre angajator a reglementarilor legale in vigoare pentru desfasurarea activitatii prin telemunca sau munca la domiciliu, daca locul de munca al parintelui permite acest lucru.

OUG nr. 132/2020:

- sprijinul financiar in valoare de 2.500 lei in scopul achizitionarii de pachete de bunuri si servicii tehnologice necesare desfasurarii

- Declaration on one's own responsibility of the other parent stating that he/she has not requested free days from his/her work;
- A copy of the birth certificate (s) of the child/children or of the document attesting the quality of parent/adopter/guardian, etc.;
- A copy of the certificate of disability of the child or adult up to 26 years of age, if applicable;
- A copy of the certificate issued by the family doctor/specialist.

The provisions of this emergency ordinance also apply if scenario 2 has been established «Daily participation of all preschoolers and students in primary education, students in grades VIII and XII, in compliance with and application of all rules protection and Partial return by rotation of 1-2 weeks of students from other middle school and high school classes, in compliance with and application of all protection rules ", respectively of scenario 3" Participation of all preschoolers and students in online activities/lessons ".

The measure of granting free days for the supervision of the child is applied during the alert state established according to Law no. 55/2020 regarding some measures for preventing and combating the effects of the COVID-19 pandemic, only after application by the employer of the legal provisions in force for the performance of the activity by means of telework and work from home, if the parent's place of work so permits.

GEO no. 132/2020:

- the financial support in the amount of 2,500 lei for the purpose of purchasing packages of technological goods and services necessary

activitatii in regim de telemunca, **nu** se va acorda angajatorilor care au transmis in registrul general de evidenta a salariatilor datele privind clauza de telemunca dupa expirarea termenului legal de inregistrare a modificarii.

to carry out the telework activity, will **not** be granted to employers who sent in the general register of employees the data on the telework clause after the legal term expires change registration.
